

# SAN ANTONIO READY TO WORK FAQS

### WHAT IS READY TO WORK?

- · Ready to Work is San Antonio's premier workforce program.
- Well-paid jobs require high-quality education and training. For too long, quality education has been out of reach for San Antonio residents. In 2020, San Antonio voters decided to invest over \$200m to offer scholarships and support services to eligible participants. No other city in the nation is investing in its residents like San Antonio.
- Ready to Work will pay for training and education programs for over 28,000 eligible adults.
  Approved courses are aligned with careers that are in high demand and that are well-paid.
  Types of training include:
  - High-school equivalency courses, like a GED.
  - Industry-recognized credential and certificate programs.
  - Associate degree programs.
  - Bachelor's degree programs.
- Ready to Work coaches will help you evaluate training, education, and employment options throughout your journey.

### WHO IS ELIGIBLE FOR READY TO WORK?

Ready to Work is intended to serve San Antonio residents that are unemployed or employed in low-paid jobs that don't make full use of their skills and abilities.

To be eligible for Ready to Work:

- You must be:
  - At least 18 years old;
  - A resident of San Antonio or a military-connected resident of Bexar County (see next question for details);



- Permitted to work in the United States;
- Willing to take assessments related to workforce readiness; and
- Willing to complete training and education aligned with high-demand careers; and
- Your household income cannot exceed 250% of the <u>federal poverty guidelines</u>, which are periodically updated. For example, as of January 2024:
  - A household of one (individual) with an annual income of no more than \$37,650 would qualify for Ready to Work.
  - An individual within a household of four with an annual income of no more than \$78,000 would qualify for Ready to Work.

# WHAT ARE ELIGIBILITY REQUIREMENTS FOR MILITARY-CONNECTED RESIDENTS?

Effective May 1, 2023, Military-connected residents living in Bexar County that otherwise meet the eligibility requirements may participate.

- For this purpose, "Military-connected" means:
  - Active-duty service members transitioning to civilian life within 12 months of separation;
  - Active-duty military spouses and dependents 18 and older (18-26 for dependent children);
  - Reservists and National Guard members, spouses, and dependents 18 and older (18-26 for dependent children); and
  - Veterans (including disabled veterans), spouses and dependents 18 and older (18-26 for dependent children).
- For military-connected residents, "household income" excludes wages of active-duty service members transitioning to civilian life within 12 months of separation (effective May 1, 2023).

### WHAT DOCUMENTATION WILL I NEED TO SHOW?

To verify eligibility, you will need certain documentation, such as the following. Your Ready to Work coach will help you compile these documents if necessary.

- Permitted to work in the US
  - Social Security card, U.S. birth certificate, U.S. citizen ID card, lawful resident citizen ID card, or Native American tribal documentation
- San Antonio residency
  - Current lease, mortgage statement, utility bill, driver's license, or ID card



- Age
  - Birth certificate, ID card, or driver's license
- Income
  - Pay stubs, or receipt of SNAP, TANF or similar benefits
- Military-connected residents only:
  - Military ID, DEERS enrollment, DD214, DD215, DD256, National Guard Bureau Form (NGB),
    Hazelwood Act documentation, Drivers License with Veteran's designation, or VA-issued
    ID card

- You are interested in improving your skills by enrolling in training and education.
- After training, you want help finding a well-paid job in a high-demand career.
- You want extra support to overcome barriers relating to training, education or to job hunting.

### WHAT SERVICES ARE COVERED BY READY TO WORK?

Ready to Work partners provide the following services at no charge:

- Personal coaching to understand your skills, education, life challenges and goals.
- Career and education planning to map out your future.
- Enrollment assistance and paid tuition for approved training programs.
- Job placement and retention services such as resume building, interviewing preparation, time management and soft skills.



- Support services to overcome financial, social, and emotional challenges.
- Emergency financial assistance to assist with training completion and job placement.
- Referrals to additional community resources to meet individual needs.
